# April 2014 Air Quality Summary Report

## Barangaroo South

This report has been compiled to summarise results of air quality monitoring at Barangaroo South in April 2014 in accordance with [EPL number 13336](#). This data is for samples taken from 1 to 30 April 2014. The data was provided to the Barangaroo Delivery Authority (the Licencee) on 20 May 2014.

Lend Lease conducts continuous air quality monitoring at Barangaroo South to measure air quality and assist the construction team implement appropriate environmental controls on site. Air quality monitoring is carried out in accordance with all relevant authority and statutory requirements. Monitoring parameters include lead, metallic compounds, polycyclic aromatic hydrocarbons, total solid particles, particulate matter less than 10 microns (PM10), and volatile organic compounds.

During mid-April bulk excavation of the basement was completed. The high volume air sampling was stopped at this time. PM10 monitoring continues.

## Location of ambient air quality monitors

Ambient air quality monitoring devices are located at four locations around the site as shown below:



*Approximate locations of air monitoring equipment*

These locations correspond to the following licenced monitoring locations:

- Northern: EPL Point 5
- Eastern: EPL Point 8
- Southern: EPL Point 13
- Water Treatment Plant Air Quality: EPL Point 17

EPL Points 14, 15 & 16 have not been monitored to date, as they are associated with works that have not commenced. EPL Point 18 was not required for this stage of the works as the remediation trial has been completed.

## Monitoring results

During April 2014 construction activities were undertaken in accordance with relevant management plans. General controls implemented during this reporting period included:

- Water cart spraying and road sweeping.
- Use of dust buster on bulk excavation, and spraying at other dust generating activities.
- Covering loads and stockpiles as appropriate.
- Housekeeping to keep exposed areas to a minimum.
- Ongoing monitoring of air and odour quality.
